**USAGE AGREEMENT:**

1. **Equipment, Usage & Term of Usage Agreement:** The undersigned, as lessee, hires from San Felipe Baptist Association or "SFBA", as lessor, one unit # 0115HEC11706 MOC. The usage fee as stated on page 1 payable.
2. **Special Instructions:** The San Felipe Baptist Association's unit equipment is reliable. Should the unit begin to deflate, check: 1) the motor has stopped in which case check the cord connection at the outlet near motor and remember to keep only the 100 foot extension cord on the outlet, 2) If the motor is continuing to run, check the air intake on the side of the motor for blockage and check both tubes at the back of the SFBA unit for snugness, re-tie if necessary, 3) If you cannot correct the problem call Perry Eaton @ 903-681-5428
3. **General Rules** to follow during use of the "SFBA" Unit:
  - Only compatible age groups and size shall play in the "SFAB" unit at the same time.
  - All riders **must remove their shoes** before playing in the "SFBA" unit.
  - To avoid neck and back injuries, **Flips are NOT allowed.**
  - **Children's safety depends on you. Your personal supervision is absolutely required.** Operator must be at least 18 years old and present. **As the Lessee of the "SFBA" Unit the safety of all riders is your responsibility.**
  - **Absolutely** no gum, candy, food, "silly string" or other sticky substances are allowed in the "SFBA" unit.
  - Do not move the "SFBA" unit from the place where it was installed. If the "SFBA" unit moves, pull the corner back to its original location of installation. **Absolutely**, keep the "SFBA" unit away from swimming pools.
  - **No pets** inside the "SFBA" unit.
4. **Safe operation acknowledgement:** Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the "SFBA" unit and Lessee agrees to observe all safety precautions.
5. **Maintenance:** Lessee agrees to keep the "SFBA" unit in the same condition as when received.
6. **Release of Liability:** The Lessee shall oversee "SFBA" unit's operation and is fully responsible for operation after receiving the unit. Lessor is not responsible for any injuries occurring to Lessee or to any persons using the leased property. Lessee further agrees to hold Lessor free and harmless against any claims; and further, Lessor shall be indemnified for any and all costs incurred due to claim from anyone; including court costs and attorney fees; and other related costs involving the use of this leased equipment. Lessee will provide own liability insurance unless otherwise specified. Lessee is responsible for the replacement value of the new leased unit in the event of theft, vandalism, fire of any act which may damage or destroy the leased property.
7. **Title to "SFBA":** Lessee agrees to keep the "SFBA" unit in his/her custody and not sublease, rent, sell, remove, or otherwise transfer such "SFBA" unit. The "SFBA" unit will remain in the property of the Lessor and may be removed by Lessor at any time after the termination of this Usage Agreement.
8. **Rain Policy:** During periods of severe weather conditions (i.e., rain high winds, etc.) "SFBA" reserves the right to cancel your reservations. If conditions are not too severe, we will give you the option of keeping it or not. If you decide to keep the unit for the term of the Usage Agreement, there will be no refunds.
